## **BETTY NOONE MEMORIAL BURSARY**

In memory of our late and distinguished treasurer, the Board of Directors have created a scholarship fund for educational / cultural purposes.

### **RULES**

- ❖ The fund shall be open to members or a member's child or spouse.
  - ❖ One application per member.
  - ❖ One course / activity per applicant.
  - ❖ The grant shall be paid for educational\* or cultural activities certified by the appropriate body for courses commenced in the period August 2010 to July 2011.
  - ❖ Grants are payable for course fees only and will not be paid to cover any ancillary costs i.e. books, living expenses etc., nor travel costs.
  - ❖ The level of grant payable to each eligible applicant will be determined by the number of applications received and the funds available to the Board of Directors in the current year.
  - ❖ **Applicants (excluding applications for members' children) must enclose with their application, written confirmation of the amount of financial assistance provided by their employer, or confirmation of non-payment of assistance.**
  - ❖ Applicants must be members of the credit union for a period of 6 months prior to the closing date of 29/07/11 and their credit union account must be in good standing during the relevant grant period (1/08/10 - 29/07/11).
  - ❖ **A copy of a Certified Receipt for payment of fees must be submitted with application. Receipts will not be returned to members.**
  - ❖ The closing date for submission of correctly completed applications is 29/07/11. **Applications / supporting documentation will not be accepted after this date.**
  - ❖ The Board of Directors decision in all matters relating to this fund is final.
  - ❖ A minimum balance of €50 (excluding the €2.54 for car draw) must be maintained in this account for a minimum of 6 months prior to the closing date of this fund. There must be a minimum of 1 transaction per month (not to include car draw) on the applicant's account
- \*Preschool fees are not included under educational activities.  
\*Gym fees are not included under educational activities.
