HIGHER EDUCATION SCHOLARSHIP APPLICATION FORM

Applicants will be required to submit a typed essay (400 – 500 words) entitled “How HSSCU’s Scholarship Would Assist Me in Furthering My Education/Career”. Handwritten essays will be excluded.

Applicants must submit the signed and completed application form, signed terms and conditions and typed essay together.

Successful applicants should provide an invoice of fees to be made payable to the relevant institution – Note that if the grant received does not cover the full fee amount, the applicant is responsible for paying the remaining balance. In year 1, fees may be paid to the student on production of receipts.

Applicants may apply for the higher education scholarship and the Betty Noone Memorial Bursary simultaneously, but can receive only one.

Payment of 2nd and subsequent years of the scholarship will be dependent on the student passing their examinations, official confirmation that the student is continuing with their studies in the same course or permitted course change and the member maintaining their account(s) with HSSCU in good standing.

The Board of Directors of HSSCU has exclusive and entire responsibility for all matters relating to the scholarship and their decisions in all matters are to be deemed final and conclusive.

The closing date for submission of complete applications is August 31st each year.

Successful applicants must make themselves available for promotional advertising purposes, including photographs, newsletters, the website and social media promotion for the duration of the scholarship and may be requested to provide a graduation photo for future marketing purposes.

Applicants will be shortlisted and may be required to attend an interview.

Students can apply for a grant for full or part time education courses.

If successful, a scholarship winner cannot apply for future scholarship funding.

Funding from employers or other scholarships for tuition fees will be taken into consideration, over the life of the grant.

The Board of Directors of HSSCU reserves the right to amend these terms and conditions as necessary any time.

Completed applications should be marked “Higher Education Scholarship” and returned to HSSCU, 5 High Street, Christchurch, Dublin 8, D08 X7T1.

The maximum value of Masters/Postgraduate scholarships is set at €15,000 with the maximum value of undergraduate courses set at €10,000.
