HSSCU SOCIAL MEDIA COMPETITION – TERMS AND CONDITIONS

1. The prize winner will receive one of three €50 JustEat digital vouchers. The winners will be selected from entrants of the competition.
2. To enter people must like, share, and comment on the competition post.
3. Entrants must be 18 years or older, members of the credit union and a resident of Ireland. Entrants will be deemed to have accepted these terms and conditions and agree to be bound by them when entering this competition.
4. This competition is not open to HSSCU staff or volunteers.
5. The competition is in no way sponsored, endorsed, or administered by, or associated with Facebook, Instagram, Twitter, or any other Social Network. This includes no obligation or responsibility to any aspect of the competition or its fulfilment.

People can enter multiple times during the competition period as long as a different social media platform is used each time; this competition runs from 10/02/2023 to 14/02/2023 and a closing time of 11.30 am. Entrants will be automatically included in the draw for the prize if you meet the eligibility criteria. Late, incomplete, or otherwise ineligible entries will be disqualified.
7. The potential winners for the prize will be selected in a random draw from among all entrants that have met the criteria during the period of the promotion. The draw will take place within 14 calendar days of the close of the promotional period.
8. The potential winners will be contacted by HSSCU by phone, email and/or direct message on social media. If a winner cannot be contacted within a reasonable time or are not able or available to accept the prize for any reason which is beyond our control, HSSCU reserves the right to withdraw the prize from the winner and pick a replacement winner.

HSSCU may use the winner's name, workplace (or hometown), competition entry comment and likeness for purposes of advertising, promotion, or publicity in any media without additional compensation and the prize winner agrees to take part in such related promotional activities as HSSCU may require.
