The winners will be selected from entrants who have answered the question correctly for the competition. The answer options are as follows; A. Dublin, B. Cork, C. Limerick and D. Galway.
- 2. To enter people must email <u>kredit@hsscu.ie</u> with and answer.
- 3. Entrants must be 18 years or older, members of the credit union and a resident of Ireland. Entrants will be deemed to have accepted these terms and conditions and agree to be bound by them when entering this competition.
- 4. This competition is not open to HSSCU staff or volunteers.
- 5. The competition is in no way sponsored, endorsed, or administered by, or associated with anyone other than HSSCU. This includes no obligation or responsibility to any aspect of the competition or its fulfilment.
- 6. People can enter only once during the competition period; this competition runs from 9.30am 16/05/2023 to 16/06/2023 and a closing time of 11.30 am. Entrants will be automatically included in the draw for the prize if you meet the eligibility criteria. Late, incomplete, or otherwise ineligible entries will be disqualified.
- 7. The potential winners for the prizes will be selected in a random draw from among correct response entrants that have met the criteria during the period of the promotion. The draw will take place within 14 calendar days of the close of the promotional period.
