## HSSCU SOCIAL MEDIA COMPETITION – TERMS AND CONDITIONS

1. The prize winner will receive €100 lodged directly into their HSSCU account. The winner will be selected from entrants of the competition.
2. To enter people must like, share, and comment on the competition post.
3. Entrants must be 18 years or older, members of the credit union and a resident of Ireland. Entrants will be deemed to have accepted these terms and conditions and agree to be bound by them when entering this competition.
4. This competition is not open to HSSCU staff or volunteers.
5. The competition is in no way sponsored, endorsed, or administered by, or associated with Facebook, Instagram, Twitter, or any other Social Network. This includes no obligation or responsibility to any aspect of the competition or its fulfilment.
6. People can enter as many times as they like during the competition period; this competition runs from 04/08/2023 to 11/08/2023 and a closing time of 09.30 am. Entrants will be automatically included in the draw for the prize if you meet the eligibility criteria. Late, incomplete, or otherwise ineligible entries will be disqualified.
7. The potential winners for the prize will be selected in a random draw from among all entrants that have met the criteria during the period of the promotion. The draw will take place within 14 calendar days of the close of the promotional period.
