2. To enter people must send the HSSCU a photo of how your seeds are coming along to [kredit@hsscu.ie](mailto:kredit@hsscu.ie) with your member name and number.
3. Entrants must have permission from their parent/guardian, be an existing member of the credit union and a resident of Ireland. Entrants will be deemed to have accepted these terms and conditions and agree to be bound by them when entering this competition.
4. This competition is not open to HSSCU staff or volunteers.
5. The competition is in no way sponsored, endorsed, or administered by, or associated with Irish Seed Savers. This includes no obligation or responsibility to any aspect of the competition or its fulfilment.
6. The competition is in no way affiliated with the voucher provider.
7. People can only enter one time; this competition closes on 15/07/2026 and a closing time of 1.00 pm. Entrants will be automatically included in the draw for the prize if you meet the eligibility criteria. Late, incomplete, or otherwise ineligible entries will be disqualified.
8. The potential winner for the prize will be selected in a random draw from among all entrants that have met the criteria during the period of the promotion. The draw will take place within 14 calendar days of the close of the promotional period.
9. The parent/guardian of the potential winner will be contacted by HSSCU by phone or email. If a winner cannot be contacted within a reasonable time of five working days or are not able or available to accept the prize for any reason which is beyond our control, HSSCU reserves the right to withdraw the prize from the winner and pick a replacement winner.
10. Publication of winner's plant photos may be available on HSSCU's website, social media, and/or in subsequent issues of HSSCU's Kredit.
11. HSSCU may use the winner's name, hometown, for purposes of publishing the winners names in any media without additional compensation and the prize winner agrees to take part in such related promotional activities as HSSCU may require.
